Ms. Rifilato has been serving as the Clerk-Recorder Division Chief for the Santa Barbara County Clerk, Recorder, Assessor, Elections Department for 5 years. Prior to her work in Santa Barbara County, she worked for the Riverside County Assessor, Clerk, and Recorder for 20 years.
